Engaging in an audit process is one of the keys to success for new customers who come to us with an existing Kentico implementation. Completing a Kentico audit as a first step allows organizations to see an immediate ROI once development work begins on their website. Here are some commonly asked questions about our Audit Process:

WHAT IS A BLUEMODUS KENTICO AUDIT?

Our Kentico Certified Development team will complete a thorough technical review of your website, including a deep dive into how it has been structured, examining how third-party integrations have been configured, investigating known issues, and uncovering any potential problems you may not have been aware of.

Once this audit is complete, BlueModus then documents and provides all results and recommendations. This report will include a prioritized list of potential fixes, upgrades, and tasks. If desired, our team can also create a larger strategic plan for ongoing support.

WHAT ARE THE BENEFITS OF THIS PROCESS?

The key to this audit method is **efficiency**. In order to most effectively support our customers, our BlueModus technologists need to have a thorough understanding of each website they manage. There is always going to be a “ramp-up” time necessary for our development team for any new ongoing customer, and the most efficient time to do this is before any other work begins.

Doing all investigation up front allows our team to:

- Uncover and plan for potential pitfalls
- Effectively prioritize a customer’s tasks, fixes, and projects
- Create uniquely customized recommendations and a strategic roadmap

HOW LONG WILL AN AUDIT TAKE?

On average, you can expect the process to take two to four weeks, from start to receipt of findings. Timing may vary based on the size and complexity of the site being reviewed.

WHAT IS INCLUDED IN THE SITE AUDIT?

From a high level our team is able to perform both a **Technical Review** and a **UI/UX & MarTech Review**.

A standard Technical Review process will include:

- An examination of current Kentico implementation (content structure, modules, templates, search, e-commerce, marketing tools, and editing experience)
- An analysis of how the site currently aligns with client's needs and requirements
- An audit of:
 - Third-party integrations
 - Server-side and front-end performance
 - Security configuration
 - Custom code
 - SEO, broken links, and metadata
 - Database setup
 - Hosting environment and deployment pipelines

In addition, a standard UI/UX and MarTech review process includes an audit of:

- Analytics
- SEO
- Performance
- User Experience

When the review is complete, you will receive:

- A printable Wiki Page that includes all results and recommendations
- A log prioritizing any fixes or updates, along with estimates for each
- An analysis of what level of ongoing support is recommended, based on audit findings and client goals

- Read-only access to any integrated third-party applications

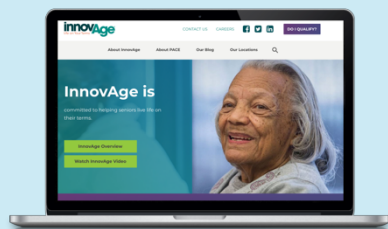
There will be **no downtime or content freezes necessary**, as our team will be reviewing a copy of your codebase and database, not the site itself.
